Rent was unaffordable for 55.2% of renters.

There are 521 residents for every mental health provider.



Address Structural Barriers to Equality

40.9% of residents are low-income (\$48,600 or less for a family of four).

The richest 5% of households have an average income 23 times greater than the poorest fifth and 5 times the typical household.
